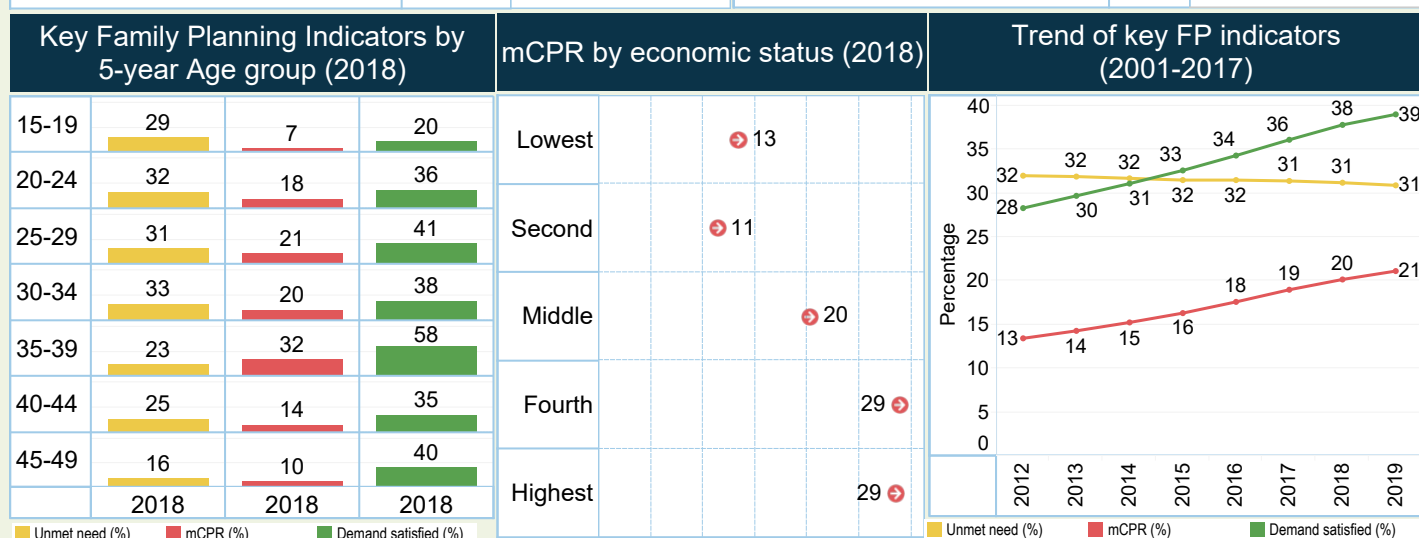

Definition of Indicators	References
<p>1. <b>mCPR</b>: % of women of reproductive age who are using (or whose partner is using) a modern contraceptive method at a particular point in time.</p> <p>2. <b>unmet need</b>: % of fecund women of reproductive age who want no more children or to postpone having the next child, but are not using a contraceptive method, plus women who are currently using a traditional method of family planning.</p> <p>3. <b>demand satisfied</b>: percentage of women (or their partners) who desire either to have no additional children or to postpone the next child and who are currently using a modern contraceptive method.</p> <p>4. <b>Unintended pregnancies</b>: Nb of pregnancies that occurred at a time when women (and their partners) either did not want additional children or wanted to delay the next birth.</p> <p>5. <b>unsafe abortion</b>: Nb of unsafe abortions that did not occur during a specified reference period as a result of the protection provided by modern contraceptive use during the reference period.</p> <p>6. <b>Facilities stocked out</b>: % of facilities stocked out of each type of contraceptive offered, on the day of assessment.</p> <p>7. <b>Method availability</b>: % of primary (resp. secondary/tertiary) service delivery points with at least 3 (resp. 5) modern methods of contraception available on day of assessment.</p> <p>8. <b>Total fertility rate</b>: Average nb of children a hypothetical cohort of women would have at the end of their reproductive period if they were subject during their whole lives to the fertility rates of a given period and if they were not subject to mortality.</p> <p>9. <b>Adolescent birth rate (ABR)</b>: Nb of births to adolescent females, aged 15-19 occurring during a given reference period per 1,000 adolescent females.</p> <p>10. <b>Maternal mortality ratio (MMR)</b>: Annual nb of female deaths from any cause related to or aggravated by pregnancy or its management per 100 000 live births.</p> <p>11. <b>Infant mortality rate (IMR)</b>: probability of dying between birth and age 1 per 1000 live births.</p>	<p>Indicators 1 to 7 From FP2020 2019 Progress Report, most recent national surveys (DHS,PMA2020, MICS,RHS and other national surveys).
