

#### **BACKGROUND**

- 1. The purpose of this document is to inform Members States about progress made in the areas of accountability, audit and risk management since the Seventieth session of the Regional Committee and the next steps. The reporting period for this document is the year from March 2020 to February 2021.
- 2. The Regional Office continues to regularly monitor the performance of budget centres against the 17 established managerial key performance indicators (KPIs) covering the enabling functions: finance, procurement, human resource management, security, information technology, travel and asset management. Performance results are regularly reported to senior management and shared with budget centres and through KPI dashboards. The Regional Office provides analyses and guidance to budget centres to address the causes of any downward trends in performance. A ranking of budget centres was established for greater transparency.
- 3. All the budget centres in the WHO African Region continue to manage their risks using a corporate risk management tool, which includes information on risk mitigation measures, with detailed action plans and timelines to ensure that risks are identified and closely managed. Overdue DFC reports is a recurring audit issue, which requires rigorous and systematic monitoring by WHO country offices and the Regional Office.

#### PROGRESS MADE/ACTIONS TAKEN

- 4. There are four tiers of rating for internal audits: "Satisfactory"; "Partially Satisfactory with some improvements"; "Partially Satisfactory with major improvements"; and "Unsatisfactory". Three internal audit reports were issued for Burundi, Guinea and Kenya. One was rated as satisfactory, while the two others were rated partially satisfactory with some improvements required, reflecting further improvements in the internal control environment in the Africa Region.
- 5. Two external audits were issued for the WHO Country Offices in Ethiopia and South Sudan. Key recommendations made for local procurement and supply chain management processes also noted the local context (limited local suppliers) and global supply chain disruptions during the COVID-19 pandemic.
- 6. The timely implementation of audit recommendations remains a management priority. Four internal audits<sup>1</sup> and two external audits<sup>2</sup> were successfully closed. Seventy-five per cent of all audit recommendations were successfully closed (a significant increase from 2020 where 60% of recommendations were closed), while 25% are outstanding. Annex 1 shows the detailed status of the implementation of audit recommendations.
- 7. Managerial KPI targets for DFC, direct implementation and human resources have not been consistently met. Management took a number of measures in early 2021 and the trend has been reversed. The three best performing WHO country offices in the various categories are presented in Table 1.

Internal audits for the following Country Offices and Regional Office services: Niger, Congo, Contracting and Procurement Services at the Regional Office, Central African Republic.




8. During the mid-term assessment of Programme budget 2020-2021, all the risk registers were updated, with 204 risks documented. Mitigation plans have been developed for 194 risks, as shown in Table 2 below:

9. The number of outstanding reports has decreased compared to previous years. As of February 2021, there were 22 overdue DFC reports totalling US\$ 1.2 million, compared to 101 in February 2020 totalling US\$ 7.5 million. The chart below presents a summary of the number of overdue DFC reports by country. Annex 2 lists the number of overdue DFC reports by country and the respective unjustified amounts.





10. A digital finance initiative was launched to move from cash payments to mobile money/bank transfers for field campaign health workers to mitigate the inherent risks of cash payment processes. Specialists from the Regional Office worked with country counterparts to implement these initiatives in a limited number of countries in 2020. Between September 2020 and January 2021, over 100 000 polio campaign workers were paid directly to their mobile money accounts in Côte d'Ivoire, Ghana and Mali.

#### **NEXT STEPS**

- 11. Member States are expected to fully collaborate with the WHO country offices to facilitate the effective implementation of the DFC accountability and assurance framework, including an annual self-assessment of the effectiveness of internal controls. Member States are also requested to expedite the submission of the outstanding DFC reports.
- 12. The digital finance initiative will continue through 2022 and Member States are requested to provide the necessary support to implement the electronic payment processes and systems.
- 13. The Regional Committee noted this report.
